Achievement of SCLS Olympians

1. Another volunteer of SCLS Arafat Ibnul Bashar was awarded with 'Best Critical Eye' in the 'Critical Eye Round' of the Law Olympiad.

Achievements of SCLS MUNners

- 1. Mohammed Sakhawat Sejan secured the Special Mention Award from committe of United Nations Human Rights Council (UNHRC) in the Noakhali Science & Technology University Model United Nations (NSTUMUN). Sejan was part of a 31-member delegate representing Chittagong University Model United Nations Association(CUMUNA) at the event. In the Same Competition SCLS volunteer GM Shuvo ensured the Best Delegate Award from the Committe of United Nations Commission on Science and and Technology for Development (UNCSTD).
- 2. Mohammed Sakhawat Sejan secured the Best Position Paper Award in the Jahangirnagar Model United Nations (JMUN). Sejan was part of a 16-member delegate representing Chittagong University Model United Nations Association(CUMUNA) at the event. - 3. Mahjubah Marzan secured the Best Delegate Award in a Model United Nations Conference organized by the Speaker's Council. In the conference, *Mahjubah* represented the Republic of Kenya in a shadow Committee of United Nations Environment Programme (UNEP).

YTS is a Nepal based international student body having its activities across Kazakhstan, India, Pakistan and Bangladesh. Tohfatur Rabbi Piyal was adjudged the Best Delegate of the UNHRC. Another SCLsian *Mohammed Shakawat Sejan* was bestowed the Special Mention Award from the same Committee.

The team comprising Raha Khan, Fahmida Bashar Prema and Shuvo Sharkar reached the Quarter Final and the team comprising Sajal Das, *Suparna Roy Piu and* Tanu Sharma made it to the Semi Final round of Bangla Debate. SCLS LAW REVIEW (January, May and September) CALL FOR PAPERS

1- Scope and Eligibility

The SCLS Law Review is a freely-available open-access online journal publishing scholarly articles. The SCLS Law Review will provide a unique forum for all those who are interested in legal studies to present their scholarly contributions. The unique offering of the SCLS Law Review is that it allows for publication on multi-dimensional legal studies. In addition, it proactively encourages analytical and comparative studies. Papers that investigate legal issues from single or multiple vantage points whether topically or jurisdictionally are equally welcomed, as are papers examining law-related interdisciplinary work. The journal is intended as a showcase for legal scholars from undergraduate and postgraduate students and early career scholars to well-established academics and legal practitioners.

2- Editorial Board

The SCLS Review is run by Senior Law students assisted by an Academic member of SCLS.

3- Publication Frequency

The journal is published in three issues a year.

The first issue is published in January (Submission period is 01 July - 31 October of the previous year).

Second issue is published in May (Submission period is o1 November of the previous year- 28 February of the same year).

The third issue in September (Submission period is o1 March – 30 June of the same year).

4- Submission and Editorial Process

All submissions are subject to a blind-review process. After an initial reading by the Editorial Board to establish suitability, we shall operate a two stages peer review process. Firstly, an appointed editor is invited to comment on the manuscript. Depending on their recommendations, we accept, advise minor revisions, request major revision and resubmission, or reject. When amendments are advised, we will agree a deadline with the author for returning the revised manuscript to us. In the case of major revision, we will approach one of the previous peer reviewers to consider the piece again. Once their comments have been returned then we make a final decision: accept further minor revisions or reject.

5- Electronic Submission

All submissions must be submitted online and through e-mail. The journal does not accept hardcopy submissions.

6- Author Guidelines

Authors must submit their details, titles, abstracts and manuscripts through SCLS email account: mc.scls17@gmail.com. To assist with blind peer review please anonymise the manuscript by giving your name and contact details in the text of your email message.

7- Word Count

Long article: Up to 6,000 words. Short article: Up to 4,000 words. Note, book review, and case note: Up to 2000 words.

8- Copyright

Those who contribute items to SCLS Law Review retain author copyright in their work but are asked to grant a licence to the SCLS enabling us to reproduce the item in digital form, so that it can be made available for access online in the open journal system and repository and website. Articles accepted for a Volume will be published as a pdf bound whole volume as well as in hyperlinked HTML version. The terms of the licence which you are asked to grant to SCLS for this purpose are as follows:

'I grant to the SCLS the irrevocable, non-exclusive royalty-free right to reproduce, distribute, display, and perform this work in any format including electronic formats throughout the world for educational, research, and scientific non-profit uses during the full term of copyright including renewals and extensions'

9- Preparation of Submissions

As part of the submission process, authors are required to check off their submission's compliance with all of the following items, and submissions may be returned to authors that do not adhere to these guidelines.

- 2. All submissions must be accompanied by an abstract of no more than 300 words.
- 3. You promise warrant that the article is your original work and submission has not been previously published, nor is it before another journal for consideration (or an explanation has been provided in Comments to the Editor).
- 4. If it contains material which is someone else's copyright, you promise that you have obtained the unrestricted permission of the copyright owner (please attach evidence of this) and that the material is clearly identified and acknowledged within the text. You also promise that the article does not, to the best of your knowledge, contain anything which is libellous, illegal, or infringes anyone's copyright or other rights.
- 5. The submission file is in Microsoft Word document file format.
- 6. Where available, URLs for the references have been provided.
- 7. The text is single-spaced; uses a 12-point Times New Roman font; employs italics, rather than underlining (except with URL addresses); and all illustrations, figures, and tables are placed within the text at the appropriate points, rather than at the end.
- 8. Style of submissions must be of academic standards and constant throughout the manuscripts. American English spelling should be used.
- 9. All submissions must comply with the latest version of Oxford Standard for Citation of Legal Authorities (OSCOLA). OSCOLA Citation Manual (4th Edition) is available

The life of the law has not been logic: it has been experience. The felt necessities of the time, the prevalent moral and political theories, intuitions of public policy, avowed or unconscious, even the prejudices which judges share with their fellow-men, have had a good deal more to do than the syllogism in determining the rules by which men should be governed. The law embodies the story of a nation's development through many centuries, and it cannot be dealt with as if it contained only the axioms and corollaries of a book of mathematics. In order to know what it is, we must know what it has been, and what it tends to become. We must alternately consult history and existing theories of legislation. But the most difficult labor will be to understand the combination of the two into new products at every stage. The substance of the law at any given time pretty nearly corresponds, so far as it goes, with what is then understood to be convenient; but its form and machinery, and the degree to which it is able to work out desired results, depend very much upon its past.
